Browns Valley School Parent Involvement Plan 2016-2017

Browns Valley School is committed to the goal of providing quality education for every child in this district. To this end, we want to establish partnerships with parents and with the community. A minimum of 4 members of the School Wide Committee will be parents of children attending our district. The School Wide Committee is responsible for developing and implementing the Parent Involvement Plan.

The School Report Card will be distributed at conferences in the fall, attached to our school wide newsletter and published in our local newspaper with the SAR report. Should our school be identified as needs improvement, a letter will be sent to parents in our district by the Superintendent. Browns Valley School is a school wide district, and will communicate with parents at fall conferences. The staff will review student data, and administration will conduct staff meetings, and allow time for discussion about strategies for parental involvement which will be communicated to parents at conferences.

3. Involve parents, in an organized, ongoing, and timely way, in the planning, review and improvement of programs under this part, including planning, review and improvement of the school parental involvement plan;

Parent surveys will be conducted at the fall and spring conferences and open house to gather input from parents about how to better meet the needs of their children. Parents are included in decision making by being on the Curriculum Review Committee, Title VII Native American Parent Committee, and School Wide Committee which will meet quarterly to insure input from a diverse group of parents.

4. Browns Valley School will offer a flexible number of meetings, such as meetings in the morning or evening, and may provide, with funds provided under this part, transportation, child care or home visits, as such services relate to parental involvement;

All parents will be invited to attend meetings to be held during our 4 open houses to review programs and policies. Childcare will be provided at no cost to the parents.

All school equipment and facilities are accessible to Title I staff for implementation of Parent Involvement planning and implementation.

Parent training will be held in September and will include an introduction to School wide Title I, and the state website and assessment data. Two-way communication will be encouraged. Meeting dates will be predetermined, corresponding with our open house activities and included in our yearlong calendar, the monthly calendar which is sent home as well as published in our local newspaper, and on our monthly bulletin. Meetings will also be posted on our school website. This will insure that parents are informed well in advance so that they can plan to attend.

7. If the school wide program plan is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the local educational agency.

Results of the surveys given at conferences will be compiled by the Title I coordinator, reported to the school wide committee, and administration will report to the local school board.

A. *Browns Valley School* will, with the assistance of its Title I schools, provide assistance to parents of children served by the school district or school, as appropriate, in understanding topics such as the following, by undertaking the actions described in this paragraph –

Minnesota state's academic content standards will be available for review during the fall open house, a workshop will be offered for parents, and staff will be available to

answer any questions parents may have. Private conferences between parents and staff will be held fall and spring to review the student's academic achievement of state's standards. Information is also available in our Parent/Student Handbook, and World's Best Workforce Report that is published on our district website. Testing results are reviewed with parents both fall and spring including MCA II's, NWEA, FASTbridge and Special Education Assessments if applicable, and are used in the development and review of Pupil Education Plans.

Staff will be available at all OPEN HOUSEs to communicate with parents and families.

- B. *Browns Valley School* will provide parents of participating children, if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practically possible.
- C. *Browns Valley School* will, with the assistance of its Title I schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
 - A training will be held to teach parents how to use the following programs at home to support academic achievement: Accelerated Reading, Accelerated Math, Study Island, and the school district's website. Parents will be invited to attend after school tutoring sessions involving their child.

Home/School visits are conducted by preschool, kindergarten, and 1st grade to help insure a good start with involving parents and helping them feel comfortable as partners in their child's education. Continuing and ongoing sessions on poverty and cultural awareness are held during staff meetings. Staff is encouraged to attend workshops that will increase cultural awareness and share ideas with each other on how to reach parents and keep them involved.

E. *Browns Valley School* will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that

Our ECFE program hosts 6 family nights, and 24 regular sessions, per year to help involve parents in activities to promote family fun and education. Browns Valley ECFE offers a lending library, and distributes free books to families at each session. Home/School visits are conducted by preschool, kindergarten, and 1st grade staff to help insure a good start involving parents and helping them feel comfortable as partners in their child's education. All staff is encouraged to attend community and school events as a way to improve parent communication and build ties with families. Continuing and ongoing sessions on poverty and cultural awareness are held during staff meetings. Staff is encouraged to attend workshops that will increase cultural awareness and share ideas with each other on how to reach parents and keep them involved. Our preschool program is an all-day-every-day program. Staff members contact parents and keep them informed by the use of phone calls, newsletters, email, and personal notes.
